### RESUME OF THE NATIONAL CONVENTION

May 20-21, 2011

We had pomp and circumstance at the formal opening, 8 of 10 nominees for Woman of the Year were in attendance with Amy Schapp, Convention Chairman, from the Omaha Chapter winning the 2011 National Woman of the Year.

At the Presidents' Brunch, the Chapter Presidents were honored by giving a short biography of each wonderful woman with their picture shown on the big screen.

At the Business Meetings, we had 64 delegates present. The National Officers elected are: Jan Oviatt, National 2nd Vice President; Diane Huntington, National 3rd Vice President; and Ida Carmouche, National Secretary.

Our Treasurer reported approximately \$829,000 in the general fund. Fidelity Investment was engaged as our investment manager. The proposed budget for 2011-2012 was presented and approved. The Survival of the NARBW Committee has an important assignment to engage a marketing firm for the purpose of increasing our membership. The Committee will report to the Chapter Presidents and Emeritus Council in six (6) months (November) as to the progress.

The results of the three (3) revisions to the bylaws are:

- Article III, Section 5(a) regarding the deletion of per capita was *not passed*. The per capita will remain at \$10.00 per person.
- Article 4, Section 2, to be eligible for the office of a Vice President a candidate shall serve as chapter president (added) and shall have been on the National Board for at least one year... The revision was passed.
- Article V, Section 4 The Secretary shall keep an accurate record of all business meetings of the Association, the Board of Directors, and the Executive Committee in a permanent manner... The revision was passed.

We lost 12 members last year and they were remembered at the Memorial Service.

We had two great speakers. The Public Affairs speaker was Lou Ann Rinn, Associate General Counsel of Union Pacific, who spoke on the legislation in the rail industry. It was a topic that fit perfectly with our purpose. At the Banquet, Lynn Wallin Ziegenbein, Executive Director of Peter Kiewet Foundation, spoke about the importance of volunteerism and thanked us for giving our time. What an articulate speaker!!

The Membership Luncheon was great with many positive thoughts and ideas on what direction the NARBW should take.

Eight (8) scholarships were given, each in the amount of \$1,750, with two (2) winners speaking at the banquet.
